In the first part E-prescribing software can be used independently or be incorporated into electronic health record (EHR) systems that include patient information such as medical history, diagnoses, clinical notes and lab test results. Allowing prescribers to access this information can reduce the potential for medical errors.

By far, the most important benefit of e-prescribing is that it can prevent medication errors caused by illegible handwriting, ambiguous nomenclature, miscommunication and lapses in knowledge of recommended dosages, drug interactions and adverse drug effects (ADEs).
